A complete copy of these rules can be obtained at the offices of radio station WXLO ("Station"), owned and operated by Cumulus Media Holdings Inc. or one of its subsidiary companies , 250 Comm ercial Street, Suite 500, Worcester, MA 17406, during normal business hours Monday through Friday or by sending a self -addressed, stamped envelope to the above address.

The Station will conduct the "WXLO Trip a Day to F-L-A Visit Florida" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

 - (i) On-Air: Listen to the Station weekdays in the 8:00 a.m., 12:00 p.m. and 4:00 p.m. hours Monday through Friday during the Contest Period. When the Station plays the "cue-to-call" message, listeners should call the Station at 508-373-1045. Caller ten (10) to the Station, as determined by the Station in its sole discretion, will be entered to win. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast*: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 5. **Winner Selection.** At approximately 6:00 p.m. ET each weekday during the Contest Period, Station will select one (1) entry for the daily Grand Prize in a random drawing from among the three (3) call-in qualifiers received by the Station that day during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verific ation contact within three (3) days of notification will result in disqualification.
