BOSTON LAWN MOWER "MOWER MONDAY" CONTEST OFFICIAL RULES

The Station will conduct the **"MOWER MONDAY" CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

Eligibility. Station will announce different keywords each week of the Contest.

Visit Boston Lawnmower or other retail locations . Find the Secret Keyword on display, and send a text message with the Secret Keyword spelled correctly to 508-88.

Station will then select one (1) potential Grand Prize winner in a random drawing from among the thirty (30) Finalists. The winning entrant will be contacted using the telephone number used to submit the entry and may be awarded the Grand Prize (subject to verification of eligibility and compliance with the terms of these rules).
